62.1 DECLARATION - Gwydion Jones expressed connection with item 7a) Planning Application No. 0/43502 Hendre Llwyn y Maen.

62.2 MINUTES – Minutes of 30th November 2016 meeting, Bro Cernyw Fund Committee meeting November 30 and council meeting December 14 were looked at and it was unanimously agreed that they were an accurate record.

62.3 ISSUES ARISING FROM THE MINUTES - OLD SCHOOL LLANGERNYW - Elen Edwards reported she would be attending a meeting in Llanfair TH soon to discuss various issues.

## 62.4 ROAD AND ENVIRONMENT MATTERS

62.4.1 MEETING SITE NEAR BRIDGE INN - Diane Roberts reported that she had attended a meeting on consumer safety and public footpath and it is understood that County Council would cut the hedge in order to improve the visibility and the owner is happy with that.

62.4.2 No further information about the bridges.

62.5 LLANGERNYW TOILET - RESOLVED to send the structural report by Conwy Council to the solicitors. Ifor Edwards offered to paint over the rust that has appeared on the fence installed outside the disabled toilet.

## 62.6 PLANNING

62.6.1 Application No. 0/43502 Variation of condition numbers 2,4,6,11 the planning permission granted under code number 0/41135 (wind turbine with a hub height of 30.52m and 45.07m of blade tip height including cabinet for wires) at Hendre Llwyn y Maen, Llanfairtalhaiarn by Mr RL Crossley. Gwydion Jones left the meeting and Gwyn Williams came to the chair.

RESOLVED to support the application but not unanimous.

Gwydion Jones came back to the chair.

62.6.2 Application No. 0/43528 Erection of agricultural shed for livestock, animal feed and agricultural equipment at Tan y Graig, Llangernyw by Mr David Roberts - RESOLVED unanimously to support the application.

62.6.3 Application No. 0/43459 Wind Turbine Bodrach, Carmel, Llanrwst - Additional information

62.6.4 Application No. 0/43567 Demolition of building and construction of timber storage and drying Building at Felin, Pandy Tudur by Mr Emlyn Roberts - RESOLVED unanimously to support the application.

62.6.5 Consultation on Planning Applications - A letter from the Chief Officer Paula Jones read that applications on paper will no longer be sent to councils after April 1 because of the cost. RESOLVED to answer by asking them to reconsider their intention as there is no super fast broadband in the area of the Community Council or in other communities in the countryside and would be very difficult for councilors to study applications online. Need to send a copy of the letter to Councillor Dilwyn Roberts.

62.7 FINANCIAL APPLICATIONS - RESOLVED to contribute £ 30 towards Macmillan Cancer Support. The Clerk had made inquiries with Ysgol Bro Cernyw to see if the Group 'Dance for All' visited the school and as the response was negative it was RESOLVED not to contribute to the company.

## 62.8 COUNCIL BUDGET AND DETERMINATION OF PRECEPT 2017/18

The Clerk prepared a sheet of the Council's payments and receipts during the year and an estimate for the next year. Raised a number of points: the need to ask for an invoice for hiring Pandy Tudur Community Centre;

WEBSITE - need to ask Arfon Parry if he knew how much use is made of the website. He sent an invoice for the work for the year and also an offer of him taking care of the website, which included a course for up to 5 people to edit the website, for £ 350 per annum. RESOLVED to accept his offer and to pay for the website from Cronfa Bro Cernyw in future. Also to inform societies through Y Gadlas and Newsletter to send information about events to Arfon Parry.

COMMUNITY SKIPS - as the skip in Llangernyw fills immediately the Clerk to inquire about hiring another skip in the village this year.

CLERK - the Chairman read a letter from the Clerk expressing her desire to resign from the post soon. Decided to raise wages by 3% (inflation) for the budget.

After discussion it was decided to keep the precept the same this year i.e. £ 9450.

62.9 DEALING WITH COMPLAINTS FROM THE PUBLIC - received an email reply to our inquiry from Luned Evans, One Voice stating that a member of the public should not be named when handling complaints nor recorded in records. RESOLVED to put this in the newsletter and to send a copy of the email to members.

62.10 NORTH WALES PILGRIM'S TRAIL PROJECT - Elen Edwards will hold a meeting soon to discuss some issues that were not completed within the project. There was a problem regarding the signing of the general route, Pandy Tudur panel incomplete and the digital hub in St Digain.

62.11 GRASS CUTTING IN CEMETERIES 2017/18 - the Clerk to advertise in the Gadlas, on the website and on the notice boards for tenders to cut the four cemeteries.

62.12 ONE VOICE DENBIGH CONWY AREA COMMITTEE - Diane Roberts and Elen Edwards were nominated to represent the Council on the Area Committee. Diane Roberts hopes to attend on 25th January.

62.13 COMMUNITY AND TOWN COUNCILS FORUM CONWY - Elen Edwards offered to attend the meeting on 26th January

62.14 ADOPTION OF TELEPHONE KIOSK - although BT phonebox Gwytherin is not on the list of those which are being disposed we should make sure that the phone stays there. Decided to put the item on the Agenda of the next meeting.

62.15 Carwyn Jones AM - advertised the meeting in Llanrwst on January 19 with the Prime Minister.

#### 62.16 LOCAL ISSUES

62.16.1 Ditch blocked under the road at the bottom of the hill Tyn Pistyll again.

62.16.2 Water flowing over the road on the bend above the Old Vicarage Home.

62.16.3 Hedge needs to be cut and grass strimmed between Glog Ddu and Pen Rhiw.

62.16.4 The Old Smithy, Llangernyw - The Clerk had sent the picture of the Building's vulnerable state forward to Conwy.

62.16.5 The Council was informed that local contractors are allowed to tender for cutting verges.

62.16.6 Stag Yard Buildings in a dangerous condition - a gate on the entrance would prevent children from going there - Public Protection Department.

62.16.7 Chippings on Gwytherin road to Llansannan still on the road although the sweeper has been passed.

62.16.8 Need roadside sweep from Gwytherin to direction of Llansannan.

62.16.9 It would be good to install hard waste tarmac in laybys to make it easier to pass on the Tyn Pistyll hill.

62.16.10 Need to know when BT will be finishing work - the Clerk has asked David Jones MP for assistance.
