65.1 DECLARATION - Ann Vaughan expressed interest in Item 7ch) and 7d)

65.2 MINUTES – minutes of 22 March 2017 were read and RESOLVED unanimously that they are an accurate record.

65.3 MATTERS ARISING

BROADBAND - information was received by Mr Peter Williams, the Welsh Government that within Fibre connection area to the Cabinet - and towards the end of their program which ends this year.

65.4 ROADS AND ENVIRONMENT MATTERS

65.4.1 It was reported that a stile on a public footpath near Tan Ffos needed attention and the gate was locked.

Gwyn Williams came to the meeting.

65.4.2 Bridges - the Clerk to inquire what was the cost of repairing the two bridges in the area and to ask why the machinery stood so long at Hendre Ddu.

65.5 REVISED FINANCIAL REGULATIONS - there was a meeting of the subcommittee before the Council meeting and RESOLVED to send a copy to everyone with the next Agenda.

65.6 PLANNING ISSUES

65.6.1 Application No. 0/43830 proposed agricultural shed a replacement to be used for livestock feed, straw and hay in Garthmyl, Pentre Isaf, Llangernyw by Mr Rhys Davies - RESOLVED unanimously to support the application.

65.6.2 Application No. 0/43853 Certificate of lawfulness for proposed placement caravan at Glog Ddu, Llangernyw by Mr Anthony Harris - RESOLVED unanimously to support the application.

65.6.3 Application No. 0/43874 Proposed agricultural building to store food and grass at Rhos Mawn, Llangernyw by Mr G Williams - RESOLVED unanimously to support the application.

65.6.4 Application No. 0/43727 Demolition and clearing old threshing barn at Bryn Gwylan - application withdrawn

65.6.5 Application No. 0/43909 Demolition and clearance threshing barn old Grade II listed at Bryn Gwylan, Llangernyw by Mr Idwal Vaughan - RESOLVED unanimously to support the application.

65.6.6 Minutes of Conservation Area Advisory Panel - received a copy of a recent meeting.

65.6.7 Harlequin Cottage, Llangernyw - received a letter from the Department of Planning indicating that they have contacted the owner about the porch and the fence. RESOLVED that we want to keep an eye on the development.

65.7 REPORT OF THE COMMITTEE CEMETERY - the Clerk gave a report of a recent meeting. Three tenders were received and resolved to accept the price of Mr D Evans of £380 per cut for this year and £400 per cut next year. Burial costs - decided to raise £10 on each. Seilo Cemetery - to see where we are by law in respect of cutting the cemetery. Gwytherin cemetery - need to ask the Council for permission to go to a solicitor to register the cemetery. RESOLVED unanimously to grant permission. Llangernyw cemetery - need to see what needs to be done there and asked for permission to remove stones near the river and removal of vegetation on the wall. RESOLVED to ask Kevin Roberts for a price to do so. The report was accepted.

65.8 CONWY COUNTY BOROUGH COUNCIL HOMECARE - accepted a reply to our concern by Mr. Vaughan Gething, the Welsh Government and by the Older People Services Manager Team Conwy Council. RESOLVED to forward the letter by email to members and raise the matter again at the next meeting.

65.9 HSBC LLANRWST BRANCH CLOSURE - RESOLVED to write to express our dismay and to complain about their proposed closure of this busy branch. Cllrs Emlyn Williams, Gwynfor Davies and the Clerk attended the Bank to collect sealed envelopes ie deeds of the cemeteries and registers of common land. RESOLVED to ask a solicitor could we keep the documents in their office in Llanrwst.

65.10 LETTER FROM PUBLIC HEALTH OFFICER - received English-only letter asking for a contribution by the Council to 'Keep it Clean - No Messing Campaign. RESOLVED unanimously that we pay our taxes for this and we did not want to contribute more.
