18.1 Croesawyd bawb i'r cyfarfod gan y Cadeirydd a chroesawodd **Ms Ann Lloyd Williams o Gyngor Conwy a Ms Suryiah Evans i sôn am Brosiect Hiraethog a Thaith y Pererinion.** Esboniodd Ms Ann Lloyd Williams bod Sir Conwy yn arwain y prosiect 'Tywysogion Gwynedd' a bod nifer o bethau ar y gweill megis arddangosfeydd yng Nghonwy, Betws y Coed, Cricieth a Chaernarfon, prosiectau bach ym Mhentrefoelas, Trefriw, Betws y Coed, Dolwyddelan, Abergwyngregyn a Beddgelert. Sir Gwynedd sy'n arwain y prosiect 'Ein Treftadaeth' a Suryiah yn gweithio arno. Bydd arddangosfa yn Llandudno yn y Mwyngloddiau ac maent yn gweithio gyda busnesau. Deallir bod Prosiect y Pererinion yn araf oherwydd bod Ann yn brysur ar brosiect 'Tywysogion Gwynedd'. Esboniodd Suryiah Evans bod gwaith ar y gweill i ddefnyddio ciosg ffôn yn Llansannan ar gyfer hysbysfwrdd ac y bydd man gwybodaeth yn Eglwys San Digain; gobeithir gosod panel yn Llangernyw yn lle'r un presennol ger yr eglwys, gwaith yn Hafodunos, panel yng Ngwytherin, gweithdai barddoni yn dechrau yn Rowen ar 16eg Rhagfyr gyda'r bardd Rhys Trimble. Community Council Meeting was held on Wednesday 27th November 2013 at 7.30 pm at Gwytherin

A member of the public - Mr Seth Jones was present .

18.1 The Chair welcomed everyone to the meeting and welcomed Ms Ann Lloyd Williams of Conwy Council and Ms Suryiah Evans to talk about Pilgrims Way/Hiraethog Project. Ms Ann Lloyd Williams explained that Conwy County leads the ' Princes of Gwynedd ' project and that many things in the pipeline such as exhibitions in Conwy , Betws -y-Coed , Criccieth and Caernarfon , small projects in Pentrefoelas , Trefriw , Betws y Coed , Dolwyddelan , Aber and Beddgelert . Gwynedd County is leading the project ' Our Heritage ' which Suryiah is working on. An exhibition in Llandudno in the Mines and work with businesses . It is understood that the Pilgrim Project is slow because Ann is busy on the project ' Princes of Gwynedd ' . Suryiah Evans explained that work is under way to use a phone box in Llansannan for billboard and an information point in St Digain Church; hoped to replace Llangernyw panel near the church , work at Hafodunos , panel in Gwytherin , poetry workshop in Rowen begins on December 16 with the poet Rhys Trimble . Hoped to launch the project in July 2014. Asked whether it could include tourism sign advertising Yew Tree Llangernyw in the project and Ms. Williams agreed she would look into the matter .

Both were thanked for attending the meeting by the Chairman .

18.3 MINUTES - Ann Vaughan proposed and all agreed that the minutes of the 23rd of October 2013 was an accurate record .

Emphasized that each item of discussion to appear on the Agenda . RESOLVED to record that an Attachment can be displayed next to the Agenda in the villages 3 days before the meeting.

18.5 ' ANIMAL ' ON TOP of chimney - Conservation Officer did not think there was an issue with this .

18.6 THE OLD FORGE , LLANGERNYW - the matter is being investigated and Health and Safety are involved .

18.7 LACK OF HEAT IN CANOLFAN BRO CERNYW EXTENSION - it was asked if there was a response to complaints about the lack of heat in the last meeting . Clerk to inquire further.

18.8 HIGHWAY MATTERS - received a letter from Rights of Way Conwy that there is no funding to do any work on the paths that is not urgent of the moment .

18:12 LLANGERNYW TOILET - plans and prices received for refurbishing the toilets by an officer of the Council . After discussion it was RESOLVED to ask the Department how much money they were willing to contribute to the plan or would it be better to go for cheaper development .

18:13 CEMETERY WORK IN GWYTHERIN - received two prices for doing the work of tidying the cemetery . RESOLVED go back to ask for more details on one application .

18:14 NATIONAL LIBRARY - received a request for back issues of the Community Council Newsletter and permission to archive the website as part of the Library's collections . It was agreed to do this .

18:15 NEWSLETTER - RESOLVED to provide information on Fuel Poverty and Recycling in the current newsletter .
