34.1 DATGAN CYSYLLTIAD – rhoddwyd cyfle i'r aelodau ddatgan cysylltiad mewn eitem ar yr Agenda. Mynegodd Ifor Edwards gysylltiad ag eitem 6 Materion Cynllunio 0/41272. Tynnodd y Cadeirydd sylw'r cyfarfod at bwyntiau 1.4 ac 20 o'r Rheolau Sefydlog sef y 'trefnir i gyfieithydd fod yn bresennol pan fo gofyn trwy drefniant blaenorol gyda'r Clerc neu'r Cadeirydd' a threfniadau'r cyhoedd i siarad mewn cyfarfodydd. - 34.5.3 CAIS RHIF 0/41300 Tynnu nifer fach iawn o flagur oddi ar 1 goeden ywen i luosogi coed ifanc yn Eglwys San Digain, Llangernyw gan Mr Ian Sturrocks – PENDERFYNWYD i gefnogi'r cais.

34.6 GRANT ADNEWYDDU PENTREFI – trafodwyd y meinciau newydd a'r blychau blodau a phenderfynwyd meddwl eto am safle i fainc Llangernyw; i gyfarfod Emlyn Williams ynglŷn a safle blwch blodau Gwytherin; bod leinio'r blychau yn bwysig cyn eu llenwi â phridd; ac i holi'r Clwb Garddio am gymorth gyda'r blodau.

34.1 DECLARATION - an opportunity for members to declare an interest in item on the Agenda. Ifor Edwards expressed connection with item 6 Planning Matters 0/41272. The Chair drew the attention of the meeting to points 1.4 and 20 of the Standing Orders which states that 'a translator can be arranged to be present when required by prior arrangement with the Clerk or the Chair' and the rules regarding members of the public to speak at meetings . RESOLVED to inform the public on the noticeboards, on the website and in the newsletter.

34.2 MINUTES - Diane Roberts proposed and Ian Griffith seconded and all agreed that the minutes of 26 November 2014 were a true record. It was also agreed that the minutes of the Cronfa Bro Cernyw Fund 26th November was an accurate record.

34.3 MATTERS ARISING

34.3.1 CEMETERY GWYTHERIN Record 33.9 - Tecwyn Evans expressed that the work was in progress and needs a meeting with the contractor soon.

34.3.2 BRO CERNYW FUND – Aelwyd Bro Cernyw had not approached the Conwy Rural Partnership for a grant and the Clerk was to ask if they still needed a grant. The Museum application will also need to be discussed in the new year.

34.4 ROAD ISSUES

34.4.1 WARNING SIGNS OF CHILDREN PLAYING - Traffic Department did not see that another warning sign could be placed near the entrance of Pandy Tudur. There might be a possibility of placing a sign ourselves and to be discussed again in Mar / April

34.4.2 WHITE LINES - no white lines have been painted following resurfacing near Rhos Isaf.

34.5 PLANNING APPLICATIONS

34.5.1 APPLICATION NO 0/41272 Retention of Altered Agricultural Access (retrospective application) at land at Hendre Llwyn y Maen, Llangernyw by Mr Robin Crossley - Ifor Edwards left the meeting. After discussion it was RESOLVED by the majority to support the application. RESOLVED to ask the Planning Department why retrospective applications come forward and what is authority's policy on such applications.

34.5.2 APPLICATION NO 0/41299 Erecting Agricultural Building (prior consent) in Merddyn, Gwytherin by Mr Bleddyn Thomas. RESOLVED to support the application. But RESOLVED to ask the Department what is the meaning of 'prior consent' on some applications.

34.5.3 APPLICATION NO 0/41300 Removal very small number of buds from 1 to propagate yew tree saplings in St. Digain, Llangernyw by Mr Ian Sturrocks - RESOLVED to support the application.

34.6 GRANT RENEWAL OF VILLAGES - discussed the new benches and flower boxes and decided to think again about the site of the bench in Llangernyw; to meet Emlyn Williams on site re Gwytherin flower box; that the boxes should be lined before filling with soil; and to ask the Gardening Club for help with the flowers.

34.7 BUDGET - The Clerk prepared expenditure and estimated expenditure for 2015/16
RESOLVED to have a look at it and discuss the precept at a meeting of the Council on January 13.
Also need to place 'Bus stop' on the next agenda.

34.8 BANKING ONLINE - Clerk received forms from the bank following paying for the
equipment grant by bank transfer. RESOLVED to leave this on the table.

34.9 FINANCIAL APPLICATIONS - RESOLVED not to contribute to Conwy Walking Festival
and Stroke Association.

34.10 TOILET LLANGERNYW - received a letter saying that the democratic process on a
transfer of the toilets has been completed and it is possible to proceed with the project now. The
officials were keen to attend a meeting of the Council to discuss further and offered to come on
January 13th or 28th January meeting It might be useful to see the plans and make sure that local
contractors have the opportunity to quote on the work. Councillor Dilwyn Roberts was thanked for
his help with the toilet and with issues in general.
