Present : Ian Griffith (Chair for the night) , Diane Roberts , Tecwyn Evans , Ifor Edwards , Emlyn Williams , Ann Vaughan , Gwynfor Davies , Gwydion Jones (late) , Gwyn Williams (later) and the Clerk .

Mr. Seth Jones - a member of the public .

Ian W Griffith welcomed everyone to the meeting.

21.1 DECLARATION - gave members the opportunity to declare a connection with an item on the Agenda .

21.2 minutes - Minutes of January 15 2014. Ann Vaughan proposed Tecwyn Evans seconded and it was voted to approve the minutes .

21.3 CLEK WAGES - Diane Roberts was still waiting for an answer from One Voice regarding this.

21.4 ROAD ISSUES – response was received to the issues of the previous meeting. County Council feels that there are enough salt bins in Llangernyw - there are 2 in Glan Collen and 1 near the toilets . There are plans to put a new drain on the lower side of the road in Petryal in the near future . The highways department has met an engineer from the Department of Structures in Rhwngyddwyffordd who want to look into rebuilding the side of the road near the bridge as soon as resources permit . They will keep a look at the location in the meantime . The Department is investigating the state of the footpath from Pont Faen to Tyn y Caeau.

21.5 PLANNING

21.5.1 PLANNING APPEAL NO 0 / 40 041 Certificate of lawfulness for existing use as a dwelling at Quarry Bungalow, Llangernyw - April 9, 2014 public inquiry .
RESOLVED not to post comments .

21.5.2 APPLICATION NUMBER 0 / 40 449 Remove stems from 3 no multi stemmed Ash trees and 1 no multi stemmed Sycamore tree, reduce 1 no Willow and 1 no Holly group, remove 1 no Cherry and 1 no Sycamore tree, remove 1 no limb on 1 no Spruce tree in Hendre House, Gwytherin by Mr Chris Holcombe . RESOLVED to support the application .

21.5.3 APPLICATION NUMBER 0 / 40 463 Two storey extension to rear of dwelling in Tyn Y Ffynnon , Pandy Tudur Mr & Mrs GA Jones. Gwydion Jones expressed interest in the application and left the meeting . RESOLVED to support the application .

21.5.4 Planning Inspectorate - application by SP Manweb Ltd for an order granting development consent for the North Wales Wind Farms Connection Project .
RESOLVED to say that we are concerned about placing pylons and electricity cables above ground for the following reasons :

a) would have an impact on children and people's health - especially when the pylons are placed close to homes in villages and to schools (magnetic effect in the

air)

b) would degrade agricultural land

c) would affect the value of properties in the area

d) we believe that it is not a ' green' way of carrying electricity .

21.6 FINANCIAL CONTRIBUTIONS - RESOLVED to donate £ 30 to 'Dance For All' as they hold workshops at Ysgol Bro Cernyw. .

21.7 OPEN ACCESS PLAY SCHEME - received a report on the activities of last year and decided to pass it on to members of the Council . RESOLVED to support the plan again this year and the cost will be £ 342 .

21.8 LLANGERNYW TOILETS - following the meeting of the Conwy Town and Community Councils Forum the Chairman and Clerk spoke to an officer and councillor with responsibility for toilets finance . They were eager to have a discussion about the development of toilets in Llangernyw and RESOLVED that the Clerk arrange a meeting with them soon .

21.9 SAND BAGS - the Clerk received a few prices for sandbags and RESOLVED to ask Mr Gwynfor Davies , Swyn y Nant if he had a place to store the bags near the river .

21.10 THE PILGRIMS PROJECT - Suryiah Evans was eager for more history of the area for the information boards . RESOLVED to inform her to contact Ann Ll Williams and ask Mrs Menna Williams for information about Capel y Cwm and Hafodunos estate information from Ms. Antoinette Sandbach , and Bethabara Chapel centenary book was available .

21:11 BOUNDARY REVIEW OF COMMUNITY COUNCILS - the report states that Pandy Tudur ward will lose one councilor and the councillor to member ratio will change from 1:63 to 1:95 . Currently there are 868 electors in the Community Council area and an anticipated increase to 926 in 3 years .

21:12 SPENDING GRANT RE. THE WEBSITE – it was discussed how to spend the money to develop the website and RESOLVED to ask Ceri Llwyd , Llanfair TH if she was interested in taking photos for the website and also the Clerk to advertise in Y Gadlas , the Newsletter , and in the villages for a person to gather information for the website .

21:13 REPORT OF COMMITTEE Conwy / Denbighshire area ONE VOICE - there was a report of a meeting in Abergele by Diane Roberts and Tecwyn Evans . During the meeting there was a discussion on decentralization and the changes on the horizon by Mr David Davies , Denbighshire CC .

21:14 REPORT OF COMMUNITY AND TOWN COUNCILS CONWY FORUM - there was a report of a meeting in Llandudno Junction by Gwyn Williams and the Clerk . There was also a request for community councils to discuss the item for the 'devolvment of services to the community councils' and report back to the next meeting .

21:15 WORK IN GWYTHERIN CEMETERY - RESOLVED Dyffryn Memorials to be asked if they would like to submit a price for work at Gwytherin Cemetery . Tecwyn Evans and Emlyn Williams would meet them there.

21.16 WELSH COMMUNITY ALLIANCE ANNUAL MEETING –we were informed that a meeting would be held in March and were keen to know if a Friday or Saturday we were most convenient . RESOLVED that Saturday would be best.

21.17 BRO CERNYW COMMUNITY CENTRE RULES AND RESPONSIBILITIES - received an information sheet relating to Health and Safety .

21:18 POLICE AND CRIME PLAN - YOUR COMMUNITY , YOUR CHOICE - RESOLVED to send the link for the website to members.

21:19 CORRESPONDENCE - decided to send information via email to members for: Post Office Advisory Council , High Sheriff of Clwyd Community Awards , Lobbying Bill , The Welsh Language in NHS Local Service , Courses One Voice North Wales .

21:20 LOCAL ISSUES

21.20.1 country roads need sweeping - leaves on the hill Plas Matw and Bryn Tân . Need to ask where the special brush obtained for the countryside is. Gutters between Felin Isa and Cae Coed and between Cwm Canol and Bryn Tân need opening.

21.20.2 Pothole in the road on Felin Isa hill - can see the ditch underneath .

21.20.3 Need to work on the side of the A548 road where vehicles have gone over the side of the field / river especially near Sgubor Newydd .

21.20.4 Standing Orders - proposing that we let the public know that we have a Standing Orders via newsletter.

21.20.5 Gwyn Williams apologized that he had failed to reach the start of the meeting and thanked Ian Griffith for being chairman.

21.20.6 Suggest to the Highways Department that they place poles with red reflectors on them where new fencing has been installed on a bend near the Tan y Ffordd , Pandy Tudur .
