35.1 DECLARATION - gave members the opportunity to declare an interest in an item on the agenda.

35.2 minutes - drew attention to the following minutes of the meeting of December 18, 2014 and decided to change them:

a) Record 34.5.1 to add 'After discussion DETERMINED by majority to support the application.

b) Record 34.3.2 to change 'Aelwyd Bro Cernyw did not receive a grant' to 'Aelwyd Bro Cernyw had not applied for a grant'. After changes Diane Roberts proposed and seconded by Emlyn Williams and all agreed that the records are accurate.

35.3 MATTERS ARISING

35.3.1 CEMETERY GWYTHERIN Record 34.3.1 - Tecwyn Evans reported that he had been seeing the cemetery with the contractor and that he hoped the work would be completed soon.

35.3.2 NEW BENCHES 34.6 - Diane Roberts and Ian Griffith had been looking for a site in Llangernyw and RESOLVED to set the bench to replace one that had broken in Glan Collen Estate.

35.3.3 PLANNING 34.5 - no reply has come to our enquiries - the Clerk to contact.

35.4 BUS STOP - admitted that work is needed on the bus stop near the school soon. The Chair offered to inquire about discounted rate for the community and suggested the possibility of asking Aelwyd Bro Cernyw do the work.

35.5 PLANNING - email received by the department of Planning regarding 0/39017 Ty'r Gof, Llangernyw indicating they had approved the revised plans for the site.

35.6 THE COUNCIL PRECEPT AND BUDGET

The Clerk draft Budget was presented and discussion on such matters as Cemetery prices, Bus Stop maintenance, public toilets Llangernyw. RESOLVED to change preconceived spending on cemeteries to £ 3200, not to include money for flowers, raising the costs of auditors to £330 pounds and room hire to £250 and retain £ 500 towards the toilets. The sum to ask for in the precept would be £ 9,450 this year. RESOLVED to contribute £ 500 from Bro Cernyw Fund to maintain the toilets next year too.

35.8 PRESENTATION ON 'FREEDOM OF INFORMATION' AND 'DATA PROTECTION'
There was a power point presentation by Diane Roberts following a course One Voice Wales arranged in Mold. It is understood that the need for the community council to appoint the amount charged for information; the public can ask the Clerk or the Chair for information; if copies of planning applications are in the possession of the Council it should register with the ICO (Information Commissioner's Office). Training DVD available – need to enquire with ICO and make copies of the scenarios.
