PENDERFYNWYD gofyn i'r Aelod Cynulliad Mr Darren Millar tybed lle oedd yr arian grant a glustnodwyd ar gyfer datblygiadau telathrebu wedi mynd os nad oedd y cwmni yn mynd ymlaen â'r cais.

46.7.2 Cysylltu Ffermydd Gwynt Gogledd Cymru – SP Energy Networks – tir ychwanegol. PENDERFYNWYD yn unfrydol i ategu ein sylwadau blaenorol ar y datblygiad.

46.7.3 CAIS RHIF 0/41886 Adeiladu un tyrbin gwynt 30.5m i'r both (48.01m i'r llafn) gyda bocs rheoli a'r holl waith cysylltiedig yn Bodrach, Carmel – gwybodaeth ychwanegol ar y cais. PENDERFYNWYD i anfon at yr Adran Cynllunio yn mynegi ein teimlad y dylai holl adroddiadau a gwybodaeth ddod gyda'r cais gwreiddiol ac felly ni fyddai angen anfon gwybodaeth ychwanegol i'r cynghorau. Community Council Meeting was held on Wednesday, November 4th 2015 at 7.30 pm at the Pandy Tudur Community Centre

46.1 DECLARATION - gave members the opportunity to declare a connection with an item on the agenda.

46.2 LLANGERNYW TOILETS - Conwy Council officials Mr Steve Teale and Mr Edward Nash were welcomed to the meeting to present an update on the development of the toilets. It is understood that they had a few problems with the original path; that solar panels will be installed on the roof; that a successful site meeting had been held with the Community Council; legal details will be completed when the work is finished; hoped to finish by the end of November. G Parry, Ruthin is the contractor. Both officers were thanked for attending the meeting by the Chairman.

Two members of the public were welcomed to the meeting.

46.3 minutes - looked at the minutes of 30th September 2015 meeting and unanimously RESOLVED that the records were correct.

#### 46.4 MATTERS ARISING

46.4.1 PEN FRON MAST, GWYTHERIN – the company did not respond to our request for clarification why the planning application was withdrawn. RESOLVED to try again to contact the Arqiva company.

46.4.2 PROJECT HIRAETHOG - the work has not been completed and the Clerk to contact again.

46.4.3 PLANTING FLOWERS IN THE TUBS - Ann Vaughan and Enid Davies have been planting flowers and bulbs and want to know what to do with the rest.

RESOLVED to ask Conwy Council if they intend to plant flowers in their tubs in the villages and if they did not could we go ahead to plant the bulbs . The bulbs were divided between the three villages. The Clerk to send a letter of thanks to Mrs. Enid Davies.

46.4.4 PAINTING THE BUS STOP - the Clerk has mentioned possible grant money to Aelwyd Bro Cernyw to do the work. Suggested that work could be part of the school's Welsh Bacalaureate course.

46.4.5 BRO CERNYW FUND - thanks to Elen H. Edwards for the application and assessment form.

46.4.6 UNDERSTANDING THE LAW COURSE - The Clerk had not had a chance to send notes out but hoped to scan and send them soon.

46.5 ACTIVE TRAVEL ACT (2013) - RESOLVED the Clerk to send the details online to members.

46.6 CONDUCT - Ann O Vaughan read a statement regarding Council members

been threatened or bullied and after a discussion on the matter it was resolved if one of the Councillors or the Clerk receives any such thing that the matter should be discussed at the next meeting of the Community Council.

#### 46.7 PLANNING

46.7.1 APPLICATION NUMBER 0/42002 Installation of telecommunication tower station which is shared with six 18 meter high antenna and associated equipment cabinets on the ground on land south of Pen y Fron, Gwytherin - application has been withdrawn. RESOLVED to ask the Assembly Member Mr Millar where the grant money which was earmarked for telecommunications developments goes if the company did not proceed with the development.

46.7.2 Connecting North Wales Wind Farms - SP Energy Networks - additional land. RESOLVED unanimously to support our previous observations on the development.

46.7.3 APPLICATION NUMBER 0/41886 Construction of a wind turbine hub to 30.5m (48.01m to the blade) with a control box and all associated works at Bodrach, Carmel - additional information on the application. RESOLVED to send to the Planning Department expressing our feeling that all reports and information should accompany the original application and therefore there would be no need to send additional information to the council. The Community Council has commented on this application a while ago.

46.7.4 Development and Building Control Manager Correspondence - received reply to our letter stating that every decision letter appears on the Conwy Council website with relevant application. RESOLVED to ask the officer can she show where the decision on the applications ie the conditions and why the application has been accepted or rejected is situated.

6.8 BRO CERNYW FUND - RESOLVED to discuss the applications following the next meeting of the Community Council.

46.9 WINTER SALT FROM CONWY COUNCIL - a message was received by the County Clerks Network that Environment Department proposes giving tonne of salt in 25kg bags per community for storage and for use in places where county grit network does not cover. The matter was discussed and many questions asked. RESOLVED unanimously to send to Mr Lyn Davies, Environment Department to say that this would be too risky to take on and what would be the insurance requirements etc. We did not see the plan working at all and we were unanimous that the yellow salt boxes, the local contractor and the large lorry gritters were working well at the moment.

46.10 FINANCIAL CONTRIBUTIONS - RESOLVED to contribute £ 30 to the Conwy Region of the Urdd but not to contribute to the International Eisteddfod or the British Red Cross.

#### 46.11 REPORT OF MEETINGS

46.11.1 CONFERENCE AND ANNUAL MEETING ONE VOICE WALES – the Chairman D Gwynfor Davies gave a report on AGM held on October 3rd in Pontrhydfendigaid. The speakers were Leighton Andrews from the Welsh Government and the Chief Executive of the National Association of Local Councils (NALC). Referred to changing borders, but nothing would happen before the election in May. There was a question and answer session following and the general

response was that community councils should accept changes with open arms, take positive approach and take on projects as a challenge.

46.11.2 REGIONAL MEETING ONE VOICE - Diane Roberts and Tecwyn Evans attended the meeting on October 14 where there was a presentation by an officer from Care and Repair Conwy and Denbigh. The next meeting will be on January 6.

46.12 CORRESPONDENCE - the Clerk to forward documents to members in particular 'Welsh Independent Remuneration Panel, Conwy Sports Awards, Public Service Ombudsman Wales Bill, Green Paper on Health.

#### 46.13 LOCAL ISSUES

46.13.1 It was brought to our attention that mail will not be collected from the box near Glan Collen in the afternoon from now on.

46.13.2 To publicize the 'sandbags' in the village in the Newsletter.

46.13.3 Speeding through the village of Llangernyw - morning and night; and racing cars starting from the village centre around 11.15pm. Suggested that the 20 mph signs are placed near Ysgol Bro Cernyw. Policeman to be invited to next meeting of the Council.

46.13.4 A suitable gate has been placed near Pont Faen - much easier to walk the public footpath.

46.13.5 Road Gwytherin to Llansannan has been closed due to damage to the bridge near Rhos Isaf - work is being done there and hope to reopen soon.

46.13.6 Feeling disappointed that the 'snow plough' has gone from Gwytherin and the contract has not been offered to other contractors in the village. It was felt that we really need a plough stationed there since the weather is very different in Gwytherin compared to Llangernyw and Pandy Tudur.

46.13.7 Need signpost for Gwytherin at Oerfa crossroads - there is only a sign for Llangernyw there.

46.13.8 Street Lamp at bottom of Gwytherin Chape hill defective.

46.13.9 Plas yn Blaenau and Bryn Aber, Pandy Tudur roadsides have not been cut.

46.13.10 Dog fouling signs should be put up between Tyddyn Uchaf and Glog Ddu, Llangernyw.
