52.1 DECLARATION - members were given the opportunity to declare a connection with an item on the agenda.

52.2 Minutes - viewed minutes of March 23rd 2016 and RESOLVED unanimously to accept as a correct record.

52.3 ISSUES ARISING

52.3.1 PUBLIC FOOTPATH OVER RIVER RHYDLECHOG - two stiles was needed on the path and some trees needed clearing. Emlyn Williams did not think that a bridge was necessary. RESOLVED to ask Conwy Council for permission to do the work and ask Kevin Roberts to look at the route and give a price. Emlyn Williams would be willing to meet on site.

52.3.2 GRASS CUTTING IN CEMETERY - Mr. Evans was prepared to do the job this year with his son in order to keep to the agreement.

52.3.3 COMMUNITY SKIPS - the skips had been ordered for May 11 in Llangernyw, May 12 in Pandy Tudur and May 13 in Gwytherin.

52.3.4 TIDYING UP LLANGERNYW - RESOLVED to be held on Saturday May 14 at 9.30 a.m. in collaboration with Keep Wales Tidy. Need to advertise through the school, on posters, on the website and in a daily newspaper.

52.4 ENVIRONMENT ISSUES

52.4.1 PAINTING BUS SHELTERS – Aelwyd Bro Cernyw and Aelwyd 7-9 had completed

the work on the two bus shelters in Llangernyw. RESOLVED to write to them to thank them and praise them for doing tidy work.

52.4.2 AFON DYFFRYN GALL BRIDGE - a site meeting was held with Mr. Bryn Shilland, Structures Department on Friday April 15 (Gwynfor Davies, Ian Griffith, Ifor Edwards, Emlyn Williams, Gwenda Vaughan, Neil Jones, Carol Walker and Clerk). In the meeting a temporary walkway was discussed which would allow pedestrians to cross the bridge and a car park in the field on the verge of the A548 road and also to erect signs to slow motorists while traveling through Pandy Tudur.

Our concerns were expressed to Councillor Dilwyn Roberts and another site meeting was mentioned with Mr David Jones MP and William Roberts of the county Traffic Department and Councillor Roberts to be held on Friday April 29th.

52.5 LLANGERNYW TOILETS - Cllr Dilwyn Roberts has asked the Department of Environment to open and run the toilets until Menter Bro Cernyw has been established and they had agreed on this. Elen Edwards offered to ask the Department what were the developments to date.

52.6 COUNCIL WEBSITE - some of the members have looked at the website and see that it needs to be updated. Elen Edwards is eager to be trained to edit the website.
