61.2 PUBLIC FOOTPATH NEAR BRIDGE INN - a site meeting is arranged for Friday December 16 and Diane Roberts is hoping to attend.

61.3 ROAD MATTERS

61.3.1 DYFFRYN GALL BRIDGE - received an email from Conwy officer, Bryn Shilland noting that work on the bridge should be completed in late January / early February.

61.3.2 HENDRE DDU BRIDGE - email noted that work should start on the bridge during February. RESOLVED to state that we are disappointed that the work has taken so long and they should make every effort to complete the work by the deadline.
