#### 55.1 COMMEMORATION TO THE LATE COUNCILLOR TECWYN EVANS

The Chair referred to a huge loss to Council and the community in the recent death of Councillor Tecwyn Evans, Gwytherin. He was a trustworthy man and loyal to the Community Council for 46 years. There will be a large gap and the Council will miss his wise advice and counsel on a variety of matters. The Chair asked everyone to stand in his remembrance.

55.2 DECLARATION - members were given the opportunity to declare a connection with an item on the agenda.

55.3 MINUTES - looked at minutes of 25th May and found that Diane M Roberts’s name had been omitted from the site meeting Ref. 54.9.3. After amending the record RESOLVED unanimously to accept the minutes as a correct record.

#### 55.4 MATTERS ARISING

55.4.1 REPRESENTATIVES – due to a vacant seat on the Council RESOLVED to discuss representatives after filling the seat.

55.4.2 DARREN MILLAR AM - he was free to attend a meeting of the Council on Tuesday, July 26th and RESOLVED unanimously to confirm this.

55.5 HIGHWAY MATTERS - received copies of letters from Mr David Jones MP to Conwy Council and reply from Head of Department for Environment, Roads and Facilities noting that application has been made for money to repair the bridge over the River Gall, Pandy Tudur and hoped to complete the work by October 2016. Also that work is underway to improve transport problems through the village and create a temporary car park in the Old Vicarage Nursing Home field. Councillor D O Roberts reported that the Department intends to start the car park and the path the week beginning July 4th and that the work on the bridge goes out to tender now. Emlyn Williams reported that the Old Vicarage Home was in a serious situation because they have lost a number of residents and have trouble getting new ones due to closure of the bridge. There was no further information regarding the Hendre Ddu bridge.

55.6 LLANGERNYW TOILETS - Toilet sign understood to be erected near the site in the near future. We received an email from the Highways dept. re brown tourist sign in Llangernyw and found that we could not have more than three small emblems on it. RESOLVED unanimously to request a sign for eatary, toilets and places of historical interest. Elen Edwards was going to talk to Steve Teale about the sign soon and Councillor D O Roberts to discuss a Tourist Information Point with tourism officer in Conwy. One Voice Wales were not able to represent us legally re transfer of toilets and D O Roberts to speak to the Legal Department regarding this. There was a broken handle on one of the toilets - Ann Vaughan to contact.

55.7 ONE VOICE WALES REGIONAL MEETING - Diane Roberts could not attend the meeting and had sent an apology. She reported that Luned Evans the Development Officer sympathized with us as a Council with the loss of Tecwyn Evans and the Regional Committee recognizes his important contribution to the meetings.

55.8 REVISED CODE OF CONDUCT - there was discussion and everyone was asked to view the updated version before the next meeting. Clerk to make paper copies of the document for 5 members. Also to ask if Darren Millar knew why the word 'interest' is changed in the Welsh version to 'benefit'.

55.9 FINANCIAL STATEMENT OF THE COMMUNITY COUNCIL AND GOVERNANCE STATEMENT 31 MARCH 2016 - the Clerk reported that the work was completed on the accounts and that the Internal Auditor Gwenda Cooper had examined the documents. The statements were submitted to the Council and signed by the Chairman. The question was raised why the External Auditors came from outside Wales and costs were higher. RESOLVED to ask Darren Millar AM to inquire about this too.

55.10 FINANCIAL APPLICATION - RESOLVED unanimously not to contribute to Shelter Cymru.

55.11 CORRESPONDENCE - reference to correspondence regarding Centenary Fields World War I; Leonard Cheshire Disability; Funding Portal CVSC; Wales Green Growth Projects

55.12 SALT BAG PARTNERSHIP PLAN - received invitation again this year from Conwy Council to join the scheme which is to be responsible for dispersing salt in communal areas where the County Gritting lorries do not reach. RESOLVED not to join the scheme but proposed that the

matter will go on the next Agenda and to see whether the County Council would be responsible for insurance.

55.13 CLERKS (SLCC) COURSE IN LLANDUDNO - SEPTEMBER 14TH - RESOLVED that the Clerk attends the course and the Council to pay the costs.

#### 55.14 LOCAL MATTERS

55.14.1 Thanks to Ann Vaughan for planting flowers in Llangernyw – it is not likely that Conwy Council will provide. RESOLVED to ask members of Gardening Club in Gwytherin and Pandy Tudur if they would like to fill the similar tubs and send the bill to the Community Council.

55.14.2 Discussed how long to wait after a request or complaint is sent to the authorities before going after the matter. The Clerk was asked to keep a record of complaints / applications and responses and to report back and discuss at every meeting of the Council.

55.14.3 Railings on roadside A548 of Memorial Garden needs attention and growth needs cutting.

55.14.4 It was asked what the situation is with the Old Smith, Llangernyw. Cllr Dilwyn Roberts replied that five years had been given to the owner to protect the site.

55.14.5 Need to remind the County Council this year to cut grass on Plas yn Blaenau road, Pandy Tudur.

55.14.6 Rhydedden phone line not working for some time - need to directly contact Alwen Mair Williams, Director of BT in Wales and to ask what is the situation regarding Super Fast Broadband in Llangernyw. Darren Millar AM also to be contacted re the matter.

55.14.7 Referred to the 'Tour de Myfs' bike ride starting soon - a trip by a number of people from the area in memory of Myfyr Thomas, Nebo - proceeds to Air Ambulance.

55.14.8 Need to inquire with the Presbyterian Church of Wales re transferring Seilo Chapel Cemetery and to inquire about the Burial Register.

55.14.9 The Clerk to check again with the Land Registry re registration of hearse shed and cemeteries.

55.14.10 Overgrown hedge between Gell and Helmydd.

55.14.11 The Clerk reported that Pandy Tudur Pilgrims Way panel is on its way.

55.14.12 Informed that the unveiling of a new sign for The Rockery, Llangernyw would be held on Thursday, July 28th at 2 pm and an invitation was offered to members of the Council.
