60.1 DATGAN CYSYLLTIAD – rhoddwyd cyfle i'r aelodau ddatgan cysylltiad ag eitem ar yr Agenda. Mynegodd Ian Griffith gysylltiad ag eitem 10 – Cais Ariannol – Eisteddfod Genedlaethol Ynys Môn

60.2 CYFLWYNIAD AR BROSIECT BWRIEDIG HEN YSGOL LLANGERNYW – croesawyd y Parch Sally Rogers a Mr Alan Benbow i'r cyfarfod a mynegwyd yr awydd i drawsnewid adeilad yr Hen Ysgol i wneud lle aros fel 'bunkhouse', tŷ golchi, lle i ofalwr fyw a chegin fechan . Y gobaith oedd ceisio am arian y Loteri. Yn anffodus roedd eu cais am arian Leader (Conwy Cynhaliol) yn aflwyddiannus. Cyrhaeddodd Einir Williams y cyfarfod ar y pwynt yma. Roeddynt yn awyddus i dderbyn cefnogaeth y Cyngor Cymuned i'r prosiect gan y bydd angen sefydlu pwyllgor lleol i redeg yr adeilad. Gofynnwyd iddynt pwy oedd yn berchen yr adeilad a'r tir. Gan nad oeddem wedi clywed gan Steve Teale ynglŷn â chyfarfod i drafod 'arwydd twristiaeth' yn y pentref penderfynwyd gofyn i'r Cynghorydd Dilwyn Roberts gysylltu â'r swyddog.

Community Council Meeting was held on Wednesday, November 30th 2016 at 7.30 pm at Canolfan Bro Cernyw

Present: Gwydion A Jones (Chair), Diane M Roberts, Ann O Vaughan, Elen H. Edwards, Ian W Griffith, Ifor G Edwards, R Emlyn Williams, Einir Williams, D Gwynfor Davies, Gwyn Williams and Clerk.

60.1 DECLARATION - members were given the opportunity to declare a connection with an item on the agenda. Ian Griffith expressed connection with item 10 - Financial Application - National Eisteddfod in Anglesey

60.2 PRESENTATION ON PROPOSED PROJECT IN OLD SCHOOL LLANGERNYW - Rev. Sally Rogers and Mr Alan Benbow were welcomed to the meeting and expressed the desire to transform the Old School building to form 'bunkhouse', laundry, small kitchen and accommodation for caretaker. The desire was to apply for Lottery funding. Unfortunately, their request for Leader (Rural Development) funding was unsuccessful. (Einir Williams arrived at the meeting at this point.) They were eager to receive the support of the Community Council to the project as a local committee will need to be established to run the building. They were asked who owned the building and grounds. They were thanked by the Chairman for attending the meeting to explain the project and it was decided to discuss the application after they leave. RESOLVED that we support that some use is made of the old school and that we are ready to nominate a representative from the Community Council to be on the steering committee once it is set up. Also to ask them to let us know who owns the building.

60.3 MATTERS ARISING –BT PAY PHONES - Conwy Council was informed by the consultation period has been extended. We need to ask BT if they can move Llangernyw phone box and also contact Suryiah Evans regarding similar work in Uwchaled. We really need to keep Gwytherin phone box as there is no mobile signal there. It is understood that the Cwm Penmachno area applied to keep their public telephone also.

#### 60.4 ROAD ISSUES

60.4.1 WATERLOO HILL – need to ask for a structural report from the Highways Dept and confirmation that the land is stable on the hill.

60.4.2 PUBLIC PATH NEAR BRIDGE INN - reported that the route coincided with the official map but a site meeting can be arranged if necessary. Diane Roberts agreed to meet the officer on site.

60.4.3 BRIDGES - need to ask what is the latest situation with the two closed bridges in the area.

60.5 LLANGERNYW TOILET - received correspondence from the solicitors noting that things are in hand and asking for a structural report on the building. The vinyl floor in ladies/disabled toilets needed attention and Conwy Council will deal with this with the contractor. RESOLVED to aim to transfer the toilets at start of next financial year. Since we had not heard from Steve Teale re. a meeting to discuss 'tourism sign' in the village decided to ask Councillor Dilwyn Roberts to contact the officer.

60.6 REVISED FINANCIAL REGULATIONS - reported that the Sub-Committee (Diane Roberts, Ann Vaughan, Elen Edwards, Gwyn Williams, Ian Griffith and Clerk) has met but a few things need to be discussed again before submitting it to the Council.

60.7 SLCC (SLCC) - RESOLVED to pay a Clerk membership of £67.00

60.8 FINANCIAL APPLICATION - RESOLVED to contribute £30 towards National Eisteddfod Ynys Môn 2017 and decided to ask Ysgol Bro Cernyw if 'Dawns i Bawb' attends the school and to put the matter on the Agenda of the next meeting.

60.9 DISCUSSING ISSUES FROM THE PUBLIC - discussed how to deal with a complaint from the public and whether to name the person. RESOLVED to contact One Voice Wales on this matter.

60.10 MOBILE PHONE MAST IN GWYTHERIN - received a letter from David Jones MP enclosing a letter from Matt Hancock MP, Minister for Culture and Digital identifying upcoming developments nationwide on mobile systems and Emergency Network Services. RESOLVED to ask him what this would mean for Gwytherin area. Also as there are Internet problems in Gwytherin and businesses failing to send online information - this should be improved without delay.

60.11 CORRESPONDENCE - the Clerk to send to the members by email.
